Enforcement Updates



1&1 Telcom EUR 9.55 million fine

The Federal Commissioner for Data Protection and Freedom of Information (BfDI), Germany issued a fine of EUR 9,550,000 under GDPR on 1&1 Telcom GmbH, a telecommunication service provider for failing to implement sufficient technical and organizational framework to prevent unauthorized access to customers personal data.



First dispute resolution decision under GDPR

The EDPB adopted its first ever dispute resolution decision under Article 65 of GDPR in the case of Twitter International Company. Earlier in January 2019 Twitter had notified the Irish

Data Protection Commission (DPC) of the data breach incident following to which DPC investigated and submitted a draft decision to EU member states. The EDPB adopted the DPC's decision on 9th November 2020.



Vodafone Espana fined for data processing

The Spanish Data Protection Agency (AEPD) announced a fine of EUR 36,000 on Vodafone Espana for processing the data for marketing purposes even after the request of erasure. This is the second time AEPD has fined Vodafone Espana.

The UK Information Commissioner's Office (ICO)

UK ICO Fines Ticketmaster

Information Commissioner levied a fine of EUR 1.25 million on Ticketmaster UK, an entertainment ticketing platform for failing to protect its customer's payment details from a cyberattack on its payment gateway. The cyberattack affected 9.4million of Ticketmaster's customers across Europe including 1.5million in the UK.

Regulatory updates around the globe



- The California Privacy Rights Act, 2020 passed by California voters. To come into force from 1st January 2023.
- New set of Codes of Practice under the Privacy Act, 2020 for credit reporting, health information, telecommunication, justice sector and superannuation released in New Zealand.
- The Parliament of Singapore approves amendments to the Personal Data Protection Act and Spam Control Act.



German Data Protection Authority (DSK) issues guidelines regulating various aspects of video conferencing.


