CJEU Judgement on consent

The Court of Justice of the European Union (CJEU) in the case between Orange Romania, a telecom provider and Romanian National Supervisory Authority for Personal Data Processing ruled that pre-ticked box consent obtained cannot demonstrate that the customer has validly given his consent. CJEU also stated that consent also becomes invalid when the customer is misled that, the contract of services will be terminated if he does not give his consent.



Actions against Amazon

A formal investigation is launched on Amazon by European commission after it was revealed that Amazon had access to non-public seller data which it aggregated to calibrate its own retail offers and make strategic business decisions resulting in market abuse.

On the other end a class action lawsuit has been filed in District Court of Delaware against Amazon under the Biometric Information Privacy Act for collecting and harvesting users' voiceprint without consent.



Whatsapp to be investigated

Bundeskartellamt, Germany's anti-trust agency recently reported that it will initiate sectoral inquiry into messenger services such as WhatsApp and other messenger services in terms of how they manage user's personal data and ensure protection of their privacy rights.


