# Enforcement updates



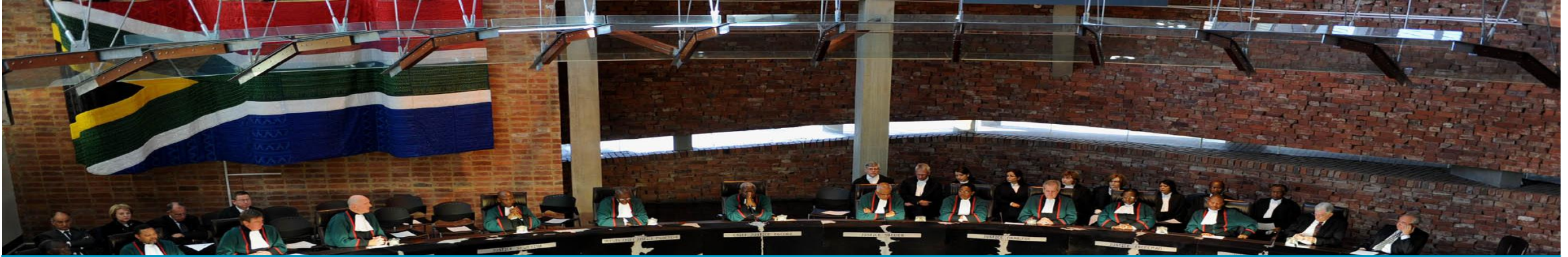
## Hospital fined for inadequate data security

Netherlands Data Protection Authority fined OLVG Hospital EUR 44,000 for violation under the GDPR. The Authority noted that the Hospital failed to adopt adequate measures for tackling unauthorized access to the protect the personal information held in medical files. The Hospital has now adopted two-factor authentication and log check mechanism.



## **Fifteenth settlement under OCR's Right to Access initiative**

The Office for Civil Rights (OCR) at the U.S. Department of Health settled an investigation under Right to Access initiative against a health system operator Renown Health. The investigation revealed that operator had failed to respond to a patient's request of electronic copy of protected health information. As a result, the operator will provide access to all of the requested records and pay USD 75,000 to settle the violation under the HIPAA Privacy Rule.



# SOUTH AFRICAN COURT



## South African Court declares surveillance law unconstitutional

The Constitutional Court of South Africa in its judgment ruled that the Regulation of Interception of Communications and Provision of Communication - Related Information Act which relates to surveillance of communication is unconstitutional as the law fails to protect fundamental rights of privacy, freedom of speech and expression, rights of access to courts. The Court also acknowledged the constitutional importance of the right to privacy, which is tied to dignity.



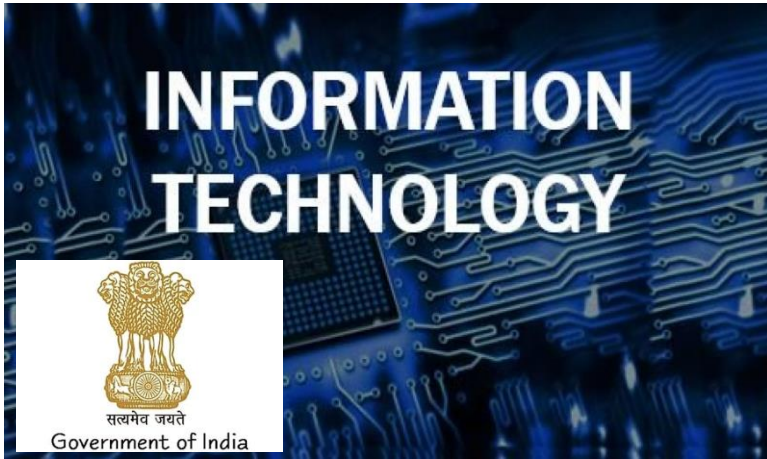
# Clearview.AI

## Swedish Police Department fined for using ClearView AI

The Swedish Authority for Privacy Protection fined the Swedish Police Department with SEK 2,500,000 for breach of the Sweden's Criminal Data Act. The Authority noted that the police department used Clearview AI for unlawfully processing biometric data for facial recognition and had failed to implement sufficient organisational measures to ensure and be able to demonstrate the processing.

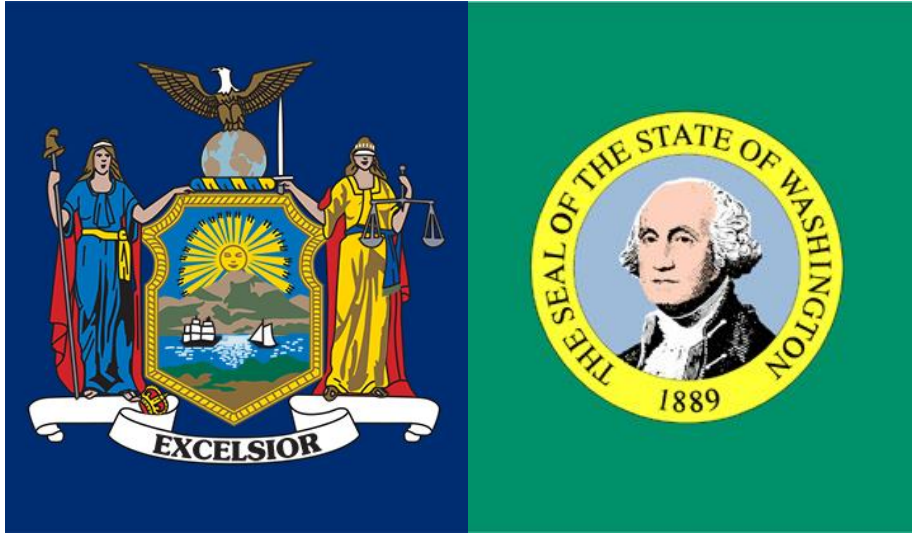
