

# Mortgage company settles Cyber Security charges

Residential Mortgage Services Inc. entered into a settlement agreement with the New York Department of Financial Services (NYDFS), to settle the violation under NYDFS Cybersecurity Regulation. The company had failed to adequately investigate and report a security incident in 2019. As part of the settlement Residential Mortgage Services agreed to pay USD 1.5 million penalty and undertake improvements to its existing cybersecurity program.



# Consulting company fined 3.24 million MOP

GPDP, Macau imposed multiple fines totalling to MOP 3.24 million on a Honk Kong based consulting firm, Haoshilai Management Consulting Co. Ltd. for violating the Personal Data Protection Act by making telemarketing calls without having a legitimate basis and informed consent.



### Facebook's GDPR consent case


None of Your Business reports that the case between Max Scherms and Facebook has reached the Austrian Supreme Court by way of an appeal. The case involves Facebook circumventing its consent obligation under GDPR in respect of its personalised advertising services.

Facebook claims that it processes personal data for the purpose of personalised advertising on the basis of fulfilling it as its contractual obligation. The lower courts had found that Facebook enjoyed discretion on basing such processing on 'consent' or 'contract'. The Supreme Court of Austria is asked to refer the case to European Court of Justice for seeking clarification on the issue.



# Public agency fined by Italian watchdog

Italy's Data Protection Authority (Garante) concluded its investigation against state's social security benefits agency Istituto Nazionale della Previdenza Sociale (INPS) and revealed that the INPS had maintained and processed incorrect or inaccurate data. Furthermore, INPS also failed to adopt GDPR principles of privacy by design, privacy by default, data minimization and accountability. As a result, Garante fined INPS EUR 300,000.









