

# Taxman can't keep GST paid by mistake : High Court

In a move that will help assessees, the Andhra Pradesh High Court has said that the GST department cannot keep the taxes paid by them due to error on their part while filing the GST forms. In a recent ruling on a writ petition, a division bench of Justices C Praveen Kumar and AV Ravindra Babu held that amounts that were paid by the taxpayer furnishing incorrect details cannot be taken as tax dues to the department. The department cannot claim that the taxpayer is barred by limitation

### Two developers directed to refund ₹30.76-crore GST benefit to 850 homebuyers in Parel project

Homebuyers who have not received the full benefit of ITC on the GST payments made to developers can approach the National Anti-Profiteering Authority (NAA) for relief. The authority, under Section 171 of the CGST Act 2017, has directed Larsen & Toubro Parel Project LLP and Omkar Realtors Developers Pvt. Ltd. to refund ₹30.76 crore with interest to 850 investors in Parel's Crescent Bay project. It has also asked the DGAP to investigate profiteering in other projects executed by the two developers
